WILL ARMSTRONG is the Marketing Director for the office of Aging Service Coordination at Texas Health and Human Service Commission. He develops public, private and nonprofit partnerships to support ASC programs. These partnerships provide older adults opportunities to learn about aging-related subjects, engage in programs that support aging



well, and to be socially connected in their communities. Prior to working with the Office of Aging Service Coordination, he educated Medicare shareholders about Medicare benefits and fraud with Wisconsin SMP, managed senior centers and congregate meal sites, and occasionally taught senior exercise classes. He has an MSW from the University of Wisconsin-Madison, and a BA from the University of Arkansas

DAN BAWDEN is well known for creating the nationally acclaimed "Certified Aging in Place Specialist or "CAPS" program in 2001 connecting trained contractors with seniors and those with mental and physical challenges. Dan is a nationally recognized accessibility and universal design remodeling expert. He has been voted "Texas Remodeler of the Year" four times



and Houston Remodeler of the Year twice". His comments regularly appear in the Wall Street Journal, New York Times, Money Magazine, Consumer Reports, and the New York Times. He has made appearances on HGTV, Animal Planet, and live talk radio shows to discuss great remodeling ideas.

SARAH BETANCOURT, MPH, is an Injury Prevention and Outreach Coordinator at Memorial Hermann Red Duke Trauma Institute where she manages community-based injury prevention programs. Ms. Betancourt leads the Southeast Texas Regional Advisory Council's Fall Prevention Workgroup and is a member of the Harris County Elder Fatality Review Team



(EFFORT). She earned a Bachelor of Business Administration from Texas Christian University and a Master of Public Health from The University of Texas School of Public Health.

CORNELIUS BLACKSHEAR leads the Military and Veterans Services program for the United Way of Greater Houston. In addition, Cornelius oversees United Way's work helping Gulf Coast communities, across 13 counties, develop strategies for improving military outreach and veteran reintegration. Outside of his work with United Way, Cornelius serves on the Advisory Board for Honor Flights Houston and the Veteran Affairs Advisory Board for Houston Community College, helping the college system connect and better meet the needs of transitioning veterans in the Houston area.

DENNIS BOREL is an Executive Director of the Coalition of Texans with Disabilities (CTD), Dennis is frequently called on for research, policy analysis and recommendations to the Texas Legislature and state agencies on issues surrounding disabilities. He serves on multiple advisory groups to state health and human services agencies and was appointed by Gov. Rick



Perry to the State Independent Living Council and by HHSC Executive Commissioners to the Promoting Independence Advisory Council and the State Medicaid Managed Care Advisory Committee. He has successfully advocated for positive change in government policy and practice in employment, transportation, housing, health care and architectural barriers to promote the full inclusion of people with disabilities in community life. He was Project Director for CTD's history-making Team Everest expedition, an internationally-recognized expedition by a team of people with diverse disabilities to the world's tallest mountain. Dennis has 35 years' experience as a senior manager of nonprofit organizations, during which time his programs have received numerous state recognitions and national awards from HUD, the Points of Light Foundation, the New York Interactive Film Festival, the Peter F. Drucker Foundation for Nonprofit Management and the Barbara Jordan Media Awards. In 2006, the University of Michigan honored him with the national James Neubacher Award for creating opportunities for people with disabilities and in 2009, he received the National Advocacy Award from the National Council on Independent Living. He is a former high school teacher and served as a Peace Corps volunteer in Morocco.

DWIGHT A. BOYKINS currently serves as the Houston City Council Member for District D. Public safety, infrastructure, and job creation are the cornerstones of Dwight's district policies. As a member of City Council, Dwight serves as Chair of the Ethics, Elections & Council Governance Committee and is a member of the following committees: Budget and Fiscal Affairs;



BFA Subcommittee on Debt Financing and Pensions; Regulation and Neighborhood Affairs; and Housing and Community Develop-

ment. Council Member Boykins actively serves as an advocate for District D constituents and works to address issues surrounding food deserts, blight, affordable housing, and community development. One of his top priorities has been to make District D one of the most economically driven districts in Houston, and with this goal in mind, Council Member Boykins made history by pushing for the creation of Tax Increment Reinvestment Zone (TIRZ) #26 for the Sunnyside community. He collaborated directly with former Mayor Annise Parker and current Mayor Sylvester Turner to identify the boundaries and recommend community and business stakeholders to serve on the Board of Directors.

In addition to gaining skills and knowledge, the support group promotes self-care for the caregiver. By teaching participants how to best take care of themselves, they are able to effectively care for their loved ones. Learning to play a music instrument has been used as a tool to offer stress reduction and as mental engagement for our group members. Starting as a monthly engagement and now meeting weekly, Kevin has taught our participants basic chords, building up to playing simple songs like "Twinkle Twinkle, Little Star." With Kevin's assistance, our Caregiver Support Group members have found a new self-care tool through music and the ukulele.



mentor during his transition back into civilian life and began a seven-year relationship with leadership expert Mr. Paul J. Meyer. Tim excelled as a non-traditional student at Grand Canyon University, finishing his education by utilizing his Post-9/11 GI Bill. He graduated with Academic Honors with a Bachelor of Science in Applied Management from the Ken Blanchard College of Business and quickly followed it with a Masters in Leadership from the same program. Volunteering in the community, Mr. Stroud worked in collaboration with the State of Texas, NAMI, SAMSHA, and BEITZ to better understand the early signs of Post Traumatic Stress and how to successfully get veterans and family members connected with resources. Hood. He continues to work with veterans and their families through Easter Seals of Greater Houston to help veterans with mental health services. One of the avenues is through providing trained service dogs for deserving veterans. Tim has two daughters, aptly nicknamed The Hurricane and The Tornado that keep him grounded. His Service Dog Colton is not only amazing but has more Instagram followers than he does!

SONIA THOMAS is currently the Nurse Facility Surveyor/Liaison for Health and Human Services, (HHS) Regulatory Services Division for Region 6. She helps to improve the care for individuals who live in nursing facilities, assisted living facilities, and day activity health facilities by enhancing communication between facility staff, regulatory services, and Ombudsman.



She establishes an ongoing dialogue between these groups by assisting in identifying goals, issues and problems for which joint efforts could be beneficial in achieving improved resident care and services. She meets regularly with providers to discuss issues and concerns that pertain to regulations and survey practices. In addition, she clarifies state and federal regulations, and creates an environment for the sharing and discussion of best practices and promotion of Senate Bill 1839. Her experience with HHSC also includes positions as a Joint Provider trainer with Education Services, and a state surveyor. She has worked for HHSC for 14 years.

MAYOR SYLVESTER TURNER Elected in December 2015, Sylvester Turner is serving his first four-year term as Houston's 62nd mayor. Since taking office, Mayor Turner eliminated a \$160 million budget shortfall in record time; led the city's remarkable rebound from Hurricane Harvey; championed historic pension reform; cheered on the 2017 World Series-winning



Houston Astros; hosted a successful Super Bowl LI; expanded municipal investments in renewable energy and led the winning bid to host the World Petroleum Congress in 2020.As the head of the energy capital of the world and the most diverse city in the nation, Mayor Turner has brought a performance-driven approach to the job, creating more responsive, streamlined and efficient delivery of city services while shoring up Houston's financial future. Thanks to his leadership, the Texas Legislature and local voters approved the pension reform package that reduces the city's liability by billions of dollars and provided a "fix" that had eluded the city for 17 years. One of the mayor's signature initiatives is Complete Communities, which aims to improve the quality of life for residents in all neighborhoods. The mayor's other priorities include filling more than 90,000 potholes on city streets, implementing a six-point holistic plan for addressing homelessness, reducing flooding and improving drainage. Mayor Turner's civic leadership has been nationally recognized through his service as a member of the U.S. Conference of Mayors Transportation and Communications Standing Committee, vice chair of the National Climate Action Agenda, member of the C40 and Global Covenant for Mayor's for Climate and Energy and an advisory board member of the African American Mayors Association. He is also the recipient of the Ohtli Award, the Mexican government's highest honor. Turner has been featured in publications and news outlets such as 60 Minutes, MSNBC, CNN, CNBC, FOX News, Wall Street Journal, Black Enterprise Magazine, Cuba Today Magazine, Ebony, New York Times, Washington Post and USA Today. Prior to his election as mayor, Turner served for 27 years in the Texas House as the representative for District 139. He worked on the House Appropriations Committee for 21 years and served as Speaker Pro Tem for three terms. He was appointed to several Budget Conference Committees to help balance the state's budget and served on the Legislative Budget Board. Mayor Turner is a life-long resident of Houston and lives in the Acres Homes community where he grew up with eight siblings. He is a graduate of the University of Houston and earned a law degree from Harvard University. He began his law practice at Fulbright & Jaworski L.L.P. and later founded the Barnes & Turner Law Firm. Mayor Turner is the proud father of First Daughter Ashley Turner, who is continuing the family tradition of public service in the healthcare field.

STEPHEN L. WILLIAMS, MEd, MPA, serves as the Director for the Houston Health Department (HHD), a full-service public health department with 1100+ employees serving the 2.1 million residents of Houston while also overseeing a \$148 million budget. Stephen is actively involved in Public Health issues at the local, state and national levels. Under Stephen's leadership, HHD has be-



come more visible and the citizens of Houston have been afforded a better guality of life. He has spear-headed the implementation and institution of several programs in HHD such as See to Succeed, Assessment, Intervention and Mobilization (AIM) and Project Saving Smiles. His most recent endeavor includes pioneering the Affordable Care Act outreach and enrollment efforts through the Enroll Gulf Coast collaborative. The collaborative has allowed stakeholders across the Gulf Coast to work together as partners with a common strategy and organization to provide outreach and enrollment to the region's estimated 1.4 million uninsured while also gaining national attention and White House support. Stephen received his Master's in Public Administration from Baruch College, City University New York, Masters of Education from the Auburn University and a Bachelor of Arts in Sociology/Social Work from Huntingdon College. He is an Alumnus of the American Leadership Forum, Houston/Gulf Coast Chapter/Medical Community Class, and is a graduate of the National Urban Fellowship Program and Executive Leadership Institute.

SHONDRA E. WYGAL is an Associate State Director of Outreach and Advocacy in Houston, Texas. As Associate State Director, Shondra manages AARP's educational campaigns and outreach efforts in the greater Houston and surrounding areas. Shondra has more than ten years of advocacy and campaign experience and has spent countless hours work-



ing on issue and political campaigns. Her experience ranges from local/county, statewide including several national issue campaigns. She is a trained mediator and an active member in her community. Shondra was appointed by Mayor Annise Parker to serve on the City of Houston's Public Safety Advisory Committee and Keep Houston Beautiful Commission. She represents AARP on the Area Planning Advisory Council of the Harris County Area Agency on Aging. She is a native of Houston, graduate of Jack Yates Sr. High Magnet School of Communications in Houston's Third Ward. She also holds B.A. degree in Politics and Government and Women's Studies from Ohio Wesleyan University.


